



CONTINUOUS ENROLLMENT AGREEMENT

In consideration of the acceptance of this Continuous Enrollment Agreement by Greater Lansing Adventist School (GLAS), the parent or legal guardian (hereinafter “the Responsible Party”) agrees with GLAS as follows:

Policy Acknowledgment: The Responsible Party agrees to accept the rules and policies of **GLAS**, including, but not limited to, the Parent-Student Handbook, the Tuition Policy (as outlined in the Parent-Student Handbook), and the Student Behavior Contract. The rules and policies of the school may be revised at any time and will be adequately communicated to school families when the revisions occur. Families agree to abide by these periodic revisions as long as their children remain enrolled in the school. The parent agrees to the policy that student transcripts will not be released to other institutions unless the student’s account is paid in full. Additionally, parents agree to abide by the policies of the Michigan Conference Education Department and the beliefs of the Seventh-day Adventist Church. This agreement supersedes any previous enrollment agreement.

Continuous Enrollment: This agreement secures the continuous enrollment at **GLAS** of the student listed above from the date of this agreement through graduation from **GLAS**. The student will not need to be re-enrolled each year; **GLAS** assumes the student will be returning unless notified otherwise. Other than graduation, this enrollment agreement will end upon 1) the written notification by the Responsible Party of the official withdrawal of the student as described in the Parent-Student Handbook, or 2) the removal of the student from enrollment by the school for financial, disciplinary, academic, or other reasons at the discretion of the school administration.

Tuition Policy: It is extremely important that the Tuition Policy, found in the Parent-Student Handbook, be read and understood in connection with this enrollment agreement. By signing this agreement, the Responsible Party acknowledges receiving, reading, and understanding the Tuition Policy and agrees to be bound by its terms and conditions.

Media Waiver: I grant **GLAS (“School”)** permission to use my child’s image and/or name in official School business media, including, but not limited to: GLAS website, newsletters, social media, e-newsletters, press releases, brochures, and magazines.

Immunization Policy: In order to ensure the health of all our students, it is necessary that each student receive all immunizations required by law. It is also required that the school be provided with current copies of the child’s immunization record. If, by 14 days from the start of the school year, it is determined that a student is in need of an immunization, he/she will be unable to attend school until it is administered, or a waiver has been provided.

The undersigned agrees to release and hold harmless the school, its agents, and employees from all claims, damages, or other liabilities for injury to my children, which are not the result of gross negligence by the school, its agents, or employees. The undersigned also agrees to indemnify the school for damages by my children. To protect the health and safety of each student, I agree to complete the **Consent Form** and **GLAS Drop Off/Pick-up Policy** *annually* for each student.

I certify that no information relevant to my children’s application has been withheld and agree to the terms of this application and to the policy of the school. I understand that acceptance of this application by **GLAS** in no way guarantees enrollment. All applicants are considered in accordance with the **GLAS** admission policy, and final decision will be made by the Admissions Committee/School Board to which the student is applying for admission.
